

# KBA Upgrade to ILM Level 7 Award in Strategic Leadership & Management



## Special bespoke Upgrade version for SLiMLG Alumni

KBA have gained ILM accreditation for a bespoke version of this new ILM Level 7 post graduate qualification to which Alumni of the KBA Strategic Leadership in Modern Local Government ILM Endorsed Award may upgrade.

This means Alumni can continue developing professional leadership within their Alumni community using approaches similar to the Knowledge Share session but without having to complete the standard six ILM knowledge workshops.

Candidates are required to commit to 6 Learning Community Activity group sessions, working on practical leadership development activities and evidencing this in 6 brief submissions.

#### **About the new Level 7 qualification**

This is the new style of ILM Level 7 vocational qualification which is designed using an Enquiry Based learning approach. It allows the learner to identify and work on the areas of leadership and management development specific to their own work context and of particular interest and relevance.

The approach is highly participative requiring candidates' to undertake a range of learning activities relating to strategic leadership within a self-managed learning community. The programme seeks to develop digital leadership by maximising the use of technology.

Learning community sessions are self-managed, online or face to face if the group wishes. There are three live virtual tutor led sessions (induction, the third Learning Community session and final presentation). Candidates will complete six individual activities and submit brief evidence in a variety of formats throughout the programme reflecting their leadership development journey.






#### Structure of the Programme

### **Qualification Content - Themes, Activities** and Submissions

The five themes covered in the programme are:

- The Strategic Leadership Environment Tools for analysing the learner's own industry or sector.
- **Strategic Leadership** Ways of understanding and making sense of theoretical approaches to leadership including leadership models.
- Developing Senior Leaders How leaders are developed, what sort of leadership development works.
- Planning and Implementing Change Robust approaches to planning at an individual level and importance of aligning personal development with strategic direction.
- Power, Politics, Influence and Networking The importance of influence in achieving personal and organisational objectives, personal and professional networks and personal brand.



- You are to identify leadership development activities that are appropriate for your leadership in your own organisational context, devise a plan for development and evaluate the extent to which the plan, or part of it, has been successful.
- This overall development task is broken down into six activities, the subject of each Learning Community Session, relating to your leadership development journey and theme and evidenced in a brief submission.

#### **Example of Learning Activity and Submission Required:**

Identify the leadership behaviours that are desired in your organisation. Consider and explain how these behaviours are put into practice by leaders? Critically evaluate the differences between stated policy and actual behaviour and offer possible explanations for those differences, if they exist. If there is a high degree of congruence between policy and behaviour, explain why this is so.

**Required :** Prepare a four-minute mp3 file of your findings which makes reference to your evidence (for example, documents you have seen or behaviours you have observed). Include a summary of the script in 8 or so bullet points on no more than one side of A4.
